It is informed that students who have passed Intermediate Vocational Courses offered by the Telangana Board of Intermediate Education (TGBIE), Hyderabad, are considered equivalent to those who have passed General Intermediate Courses of the TGBIE. These Intermediate Vocational Passed students are eligible for admission into BA/B.Com. courses on par with the conventional (General) Intermediate Students (please refer Annexure enclosed).

Similarly, Computer Science Students from the Intermediate Vocational Stream are eligible for admission into B.Com. Computers. Additionally, the Students who passed in Vocational stream are eligible for admission into B.Sc. Degree courses and EAPCET, to seek admission into B.Tech. and other Professional Courses on merit, provided they have passed the Bridge Course.

The Bridge Course includes subjects such as Mathematics, Physical Sciences (i.e., Physics & Chemistry), and Biological Sciences (i.e., Botany

& Zoology). Vocational students who have passed the Bridge Course, either with Mathematics and Physical Sciences or Biological Sciences and Physical Sciences, are considered equivalent to the Students who have passed MPC or Bi.P.C of conventional (General) Intermediate course of the TGBIE.

Therefore, there is no need to issue Equivalency / No Objection Certificates for these Vocational Students, and they should be treated on par with other Intermediate Students of the Telangana Board of Intermediate Education, Hyderabad.

It is requested that all the Principals of Degree Colleges in your jurisdiction may be informed about the equivalency of Vocational Courses as stated above. Students should be admitted without the insistence of **“No Objection/Equivalency Certificate”** to avoid inconvenience during the admission process of Vocational Students.
